General safety instructions (GPSR)

Improper or incorrect assembly of the baby cradle can lead to serious accidents and injuries and poses **serious safety risks**.

Please observe the following instructions carefully:

WARNING – Risk of suffocation and death (SIDS)

- **Always** place your baby **on their back** to sleep to minimise the risk of sudden infant death syndrome (SIDS).
- **Do not** use **additional pillows, blankets, soft toys or padding** in the cradle. These increase the risk of **suffocation or overheating**.
- **Only** use **the mattress supplied**.

WARNING – Risk of falling and injury

- **Never** place the cradle **on tables, beds or other furniture** to prevent falls.
- **Only** place the cradle on a **stable, level and non-slip surface**.

WARNING – Use only within the limits

- **Only** use the cradle **for newborns and babies** who cannot yet **sit up, roll over or push** themselves **up on their hands and knees** without assistance.
- Observe the **maximum weight limit** (e.g. **9 kg**) and stop using the cradle as soon as your baby reaches this limit or becomes **more mobile**.

CAUTION – Environment & location

- **Do not** place the cradle **near windows, curtains, cables** or other potential hazards.
- Keep the cradle **away from heat sources** (e.g. heaters, fireplaces) and **direct sunlight**.

NOTE – Assembly & regular checks

- Regularly check that the cradle is **securely assembled** and **tighten any loose screws**.
- **Never** leave your baby **unattended** in the cradle when they are **awake or restless**.

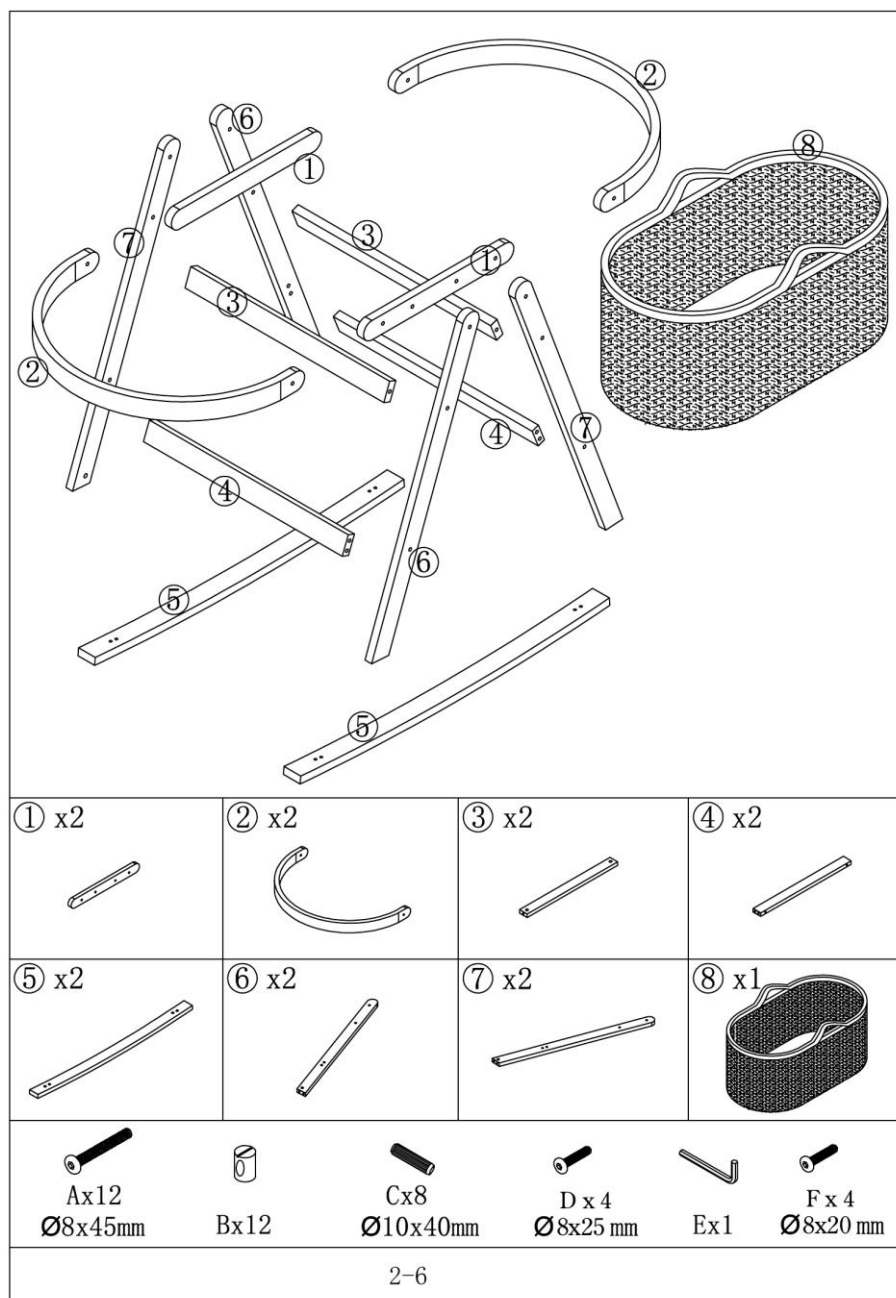

Care instructions – washing symbols according to GINETEX



The mattress cover of the baby cradle is removable and can be cleaned according to the GINETEX care symbols. These internationally standardised symbols are binding, even if they are not always self-explanatory.

The mattress cover can be washed at 30°C on a gentle cycle. A gentle drying process at a maximum of 60°C is suitable for drying. The cover must not be ironed or bleached, as this can damage the material and impair the function of the cover.

Please follow these care instructions carefully to ensure the hygiene, dimensional stability and longevity of the mattress cover.
