Manual / Operating Instructions

We deliberately do not provide printed operating instructions, thereby saving several tonnes of paper every year. At the same time, we can update our electronic operating instructions at any time so that you always have the latest version to hand.

Even though many functions can be operated intuitively, please take **five minutes** to **read through the manual**. It is important to use the product in accordance with the operating instructions so that you can enjoy it for a long time, everything works safely and unnecessary annoyance is avoided.

General safety instructions (GPSR)

Improper cleaning can not only impair the function of your bottle warmer, but also lead to **serious safety risks**. Please observe the following instructions carefully:

- Never clean the bottle warmer **in the dishwasher**, **do not use it in a steriliser** and **do not wash it under running water**.
- Water entering the device can damage the electrical components and the battery. This can **lead to short circuits, irreparable battery damage, fires, electric shocks or other accidents**.
- To ensure the safety, function and longevity of the bottle warmer, the product must only be used in accordance with the manual and manufacturer's instructions.
- Leaving the battery-powered device connected to a power source for long periods of time, especially overnight, can **significantly impair battery performance** and **service life** and lead to increased wear and tear. In such cases, any warranty or guarantee claims are excluded.
- LIINI® **must never be operated unattended** (e.g. overnight).
- The bottle warmer is only suitable for briefly warming up baby food, e.g. when out and about, travelling, on trips or on holiday - always under adult supervision.
- The product may **only** be operated **by adults**.
- The LIINI® bottle warmer **must be kept away from children** at all times and must not be used as a toy.
- Check the bottle warmer for **visible defects** before each use.
- Clean the baby bottle warmer thoroughly before using it for the first time.
- LIINI® may only be used at ambient temperatures of **at least 4 °C** and **a maximum of 50 °C**.
- **Do not use aggressive cleaning agents**, as these can cause cracks or discolouration in the housing. In such cases, the product must no longer be used.
- Wash your hands thoroughly before you start warming the baby bottle.
- **Do not** use the product **in direct sunlight** or at very high ambient temperatures - always use it in the shade.
- Do not touch the heating plate after use - there is **a high risk of burns**.
- The product must be thoroughly cleaned after each use and after it has cooled down completely.
- **Only charge the device with the original LIINI® charging cable supplied**. For use on the go, we recommend the LIINI® power bank.
- The sealing ring may be removed for cleaning. Afterwards, make sure that it is installed in the correct direction (depending on the bottle brand used).
- LIINI® contains a built-in rechargeable battery and must therefore **not** be used **near strong magnetic fields**.
- Once fully charged, the bottle warmer must be disconnected from the power supply. **A permanently connected USB cable will damage the battery**.
- Keep the product out of the reach of children at all times. **Children must never play with the bottle warmer**. Always check the milk temperature with **your wrist** before feeding.
- The device must not be opened, modified or repaired by yourself. Repairs may only be carried out by authorised technicians.

Cleaning instructions

Cleaning the warming area (heating plate)

LIINI®'s high-quality cleaning and disinfecting wipes offer an efficient and convenient solution for thorough cleaning and disinfecting our products. They are ideal for cleaning our bottle and baby food warmers, breast pumps and accessories, or your baby bottles when you are on the go.



- Made from bamboo: The wipes are made from bamboo viscose – for the environment and our children's future.
- 2-in-1 protection: Removes dirt and eliminates up to 99.9% of all bacteria, viruses and fungi
- Fast and effective: thanks to their special formula, the wipes work in seconds and leave no residue
- Versatile: Suitable for the heating area of bottle and baby food warmers, our breast pump components and your baby bottles
- Fragrance-free: Cleans and disinfects without artificial scents or flavours
- Alcohol-free: Alcohol-free for your baby
- Compostable: simply dispose of the wipes with your green waste

Cleaning stubborn stains

For heavy soiling such as limescale deposits, you can leave a mixture of water and vinegar to work overnight. Please proceed as follows:

1. Fill the warming area of the bottle or baby food warmer halfway with boiled water.
2. Now add some apple cider vinegar to the boiling water. Make sure there is a 10 mm gap between the water and the rim of the warming area. This ensures that the mixture of water and vinegar does not overflow and enter the appliance.
3. If you spill any mixture, remove the residue with a damp cloth and dry the housing. Otherwise, the colour of the housing may change.
4. You can now leave the mixture to work overnight. Make sure that the product is out of reach of your children.
5. The next day, you can pour out the solution and clean up any residue with a damp cloth.
6. The device must be completely dry.

To clean the housing, simply wipe off any milk or porridge residue with a damp cloth. Do not use aggressive cleaning agents, as these may cause changes to the housing. The cloth must not be dripping wet, as this may cause water to enter the device (see safety instructions, page 1).

Cleaning the lid of the LIINI® 3.0 PRO

The lid of the LIINI 3.0 must **not be cleaned in the steriliser**.

The high temperatures in the steriliser can cause the lid to deform. This may prevent it from closing properly, which would compromise the proper functioning of the LIINI 3.0.

Recommended cleaning of the lid:

- Clean the lid by hand with warm water and mild washing-up liquid.
- Then rinse thoroughly.
- Then leave to dry completely in the air.

Information on the WEEE Directive 2012/19/EU

Meaning of the crossed-out wheelie bin symbol



All our electronic devices (bottle warmers, porridge warmers, sleep aids) are marked with the crossed-out wheelie bin symbol.

The crossed-out wheelie bin symbol means that **you are legally obliged** to dispose of these devices separately from unsorted municipal waste, i.e. old devices must be disposed of separately from household waste. Non-permanent batteries or rechargeable batteries must be removed beforehand and disposed of separately.

All rechargeable batteries in our products are permanently installed, so you can **dispose of** the products **as a whole**.

A bar under the wheelie bin means that the product was placed on the market after 13 August 2005.

Options for returning old appliances (WEEE Directive 2012/19/EU)

Owners of old appliances can return them to the return or collection points set up and made available by public waste disposal authorities to ensure proper disposal.

Personal data (WEEE Directive 2012/19/EU)

All end users of waste electrical and electronic equipment are advised that they are responsible for deleting personal data on the waste equipment to be disposed of.

Whenever reference is made to batteries or accumulators below, this refers to waste batteries or accumulators.

Meaning of the crossed-out wheelie bin symbol (Battery Directive 2006/66/EC)

The crossed-out wheelie bin symbol means that you are legally required to dispose of batteries or accumulators separately from unsorted municipal waste. In other words, they must be disposed of separately from household waste. If batteries or accumulators contain more than **0.0005% mercury** by weight, more than **0.002% cadmium** by weight, or more than **0.004% lead** by weight, they are labelled with the chemical symbols of the relevant metals (Hg, Cd, Pb) for which the limit value is exceeded.

Options for returning batteries or accumulators (Battery Directive 2006/66/EC)

After use, owners of batteries or accumulators can return them **free of charge** to the return or collection points set up and made available by public waste disposal authorities, or directly to retailers, to ensure proper disposal.

Waste prevention measures and measures to prevent littering (Battery Directive 2006/66/EC)

Reduce battery waste as much as possible by using batteries with a longer service life or rechargeable batteries. Do not leave batteries or battery-powered electrical and electronic equipment lying around. This helps prevent littering and protects the environment—for the protection of our children.

Options for preparing used batteries for reuse (Battery Directive 2006/66/EC)

Check whether used batteries can be recycled.

Potential effects of the substances contained in batteries on the environment and human health (Battery Directive 2006/66/EC)

Lithium-containing batteries in particular must be handled with care due to the specific risks they pose, such as **fire hazards** or, in the case of button cells, a **risk of swallowing**.
